Passenger train provides free rides between Des Moines and Iowa City and return on January 11, 2007 for Culver-Judge Inaugural Events

(Iowa City) – Iowa Interstate Railroad, Ltd., Burlington Northern Santa Fe Railroad, and the Iowa Association of Railroad Passengers are cooperating to operate a free passenger train service on Thursday, January 11, 2007, between Des Moines and Iowa City. The train will leave Iowa City and return to Des Moines about thirty minutes after the event at Hancher Auditorium ends.

The passenger rail cars have been donated by Burlington Northern Santa Fe Railroad and Iowa Interstate Railroad, Ltd. Locomotive power and crews are being donated by the Iowa Interstate Railroad. Ltd.
